Pre-Requisites for Application to AEMT Pathway

- Graduated from high school or have a GED
- Current certification as an **Emergency Medical Technician** in the Commonwealth of Virginia that must remain valid throughout the course
- Current certification in **American Heart Association CPR for BLS Providers** that must remain valid throughout the course

Advanced Placement Information

- The EMS-Paramedic Program **does not give credit** for Experiential Learning. The Program does allow for Advanced Placement credit into the program, as outlined below. The student is still responsible for the skill requirements of each Advanced Placement course and this could require additional time spent in lab/clinical opportunities.
- Current certification in **AHA BLS for Healthcare Providers** will allow for the student to be given credit for HLT 105-Cardiopulmonary Resuscitation.
- Advanced Placement as a Virginia EMT into the Health Technology-EMS Advanced track **will require an EMS skills verification** by the EMS Program Director or designee before starting the AEMT courses. Upon verification, the student will be awarded credit for the following courses: EMS 111 Emergency Medical Technician-Basic (7) & EMS 120 EMT-Basic Clinical (1)
